Proposition #1 - Proposed 2014-15 Budget

Peru Central School District's Board of Education has established a \$42,393,586 proposed expenditure plan for voter consideration noon until 9 PM, Tuesday, May 20, 2014 in the district's Junior/Senior High School gymnasium. The proposed budget calls an increase of \$1,419,540 compared to the current year's budget. This increase is largely offset by state aid. The tax levy is forecasted to increase 1.92% which is below the tax levy limit. Next year's proposed levy increase is actually a decrease from this year's levy increase of 3.95%. The proposal calls for an estimated tax rate increase of 1.65% from \$19.54 to \$19.86 per assessed \$1,000 of property value.

A great deal of planning and discussion went into attempting to sustain programs and support services into next year. Given a forecasted budget surplus in 2013-14 and additional state-aid in 2014-15, Peru Central School District is proposing to maintain 2013-14 programs into 2014-15 and provide some modest enhancements. The following represents enhancements slated for the 2014-15 Budget:

- 1. The equivalent of one (1) Special Education Teacher and a Part-time Speech Language Pathologist.
- 2. The equivalent of one (1) School Behavior Support Counselor and a Part-time Elementary Counselor.
- 3. The implementation of a Continuing Education Program.
- 4. Part-time Elementary Math Interventionist Teacher.
- 5. Part-time Clerical Position.
- 6. Transportation Expenses related to Field Trips, Post Season Athletic Competitions and Student Activity Events.
- 7. Some additional Instructional Material & Supply Funds which had been drastically reduced over the last few years.

Proposition #2 – Capital Project

DESCRIPTION

The District proposes a \$1,805,000 capital project funded with state building aid and a capital reserve of \$344,794 which is estimated to offset the entire local share. This project, if approved, will be scheduled for the summer of 2015.

The following work scope items have been estimated for reconstruction in the proposed capital project at the District's High School/Middle School, Elementary, and Transportation facilities.





Proposition #3 - School Buses

The District proposes the purchase of three (3), regular, sixty-five (65) passenger, school buses and a mini-van type vehicle capable of transporting students at a total cost not to exceed \$375,000. The cost of this proposition would be largely offset by transportation aid which is approximately 82%.
