I am a qualified and registered voter of the Peru Central School District in which I reside in that I am or will be eighteen (18) years of age or over on May 17, 2023, a citizen of the United States and have or will have resided in the District for thirty (30) days next preceding May 17, 2022, and I am registered in the District.

I will be unable to appear to vote in person during all hours on the day of the School District (Vote &) Election for which the absentee ballot is requested because I am or will be on such day:
